Responsibility for society

As a responsible operator in the book sector, Kirjavälitys has a role as a promoter of Finnish reading skills, learning, and education and culture, and we want to foster these values with our own solutions. We promise to provide high-quality and ethically produced logistics, wholesaler service and digital service to the best of our abilities.

Our quality system has been awarded the ISO 9001 certificate, and it is assessed annually by an external auditor.

Responsibility for the environment

Kirjavälitys bears responsibility for preserving the diversity of the environment. We deliver products to our customers with a minimum impact on the environment, using centralized purchases and deliveries and our digital services.
